
Background:

On May 18, 2017, the City Council called an election to submit to the voters a proposed an ordinance of the City of Brisbane amending section 5.20.100 of the Brisbane Municipal Code to increase the business license tax charged to recycling establishments.


Discussion:

The attached Resolution declares the results of the election that was held on November 7, 2017 regarding Measure E. The certification of votes from the County of San Mateo is attached as Exhibit A.

The number of votes cast at said election was 1170; 877 in favor and 225 against. Measure E, an ordinance of the City of Brisbane amending section 5.20.100 of the Brisbane Municipal Code to increase the business license tax charged to recycling establishments, passed by the majority needed.

RESOLUTION NO. 2017-60

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRISBANE
ADOPTING COUNTY OF SAN MATEO CERTIFICATION OF VOTES
AND DECLARING RESULTS OF MEASURE E, AN ORDINANCE OF THE CITY OF
BRISBANE AMENDING SECTION 5.20.100 OF THE BRISBANE MUNICIPAL CODE TO
INCREASE THE BUSINESS LICENSE TAX CHARGED TO RECYCLING
ESTABLISHMENTS, AT THE MUNICIPAL ELECTION HELD ON NOVEMBER 7, 2017**

WHEREAS, a General Municipal Election was held in and throughout the City of Brisbane on the seventh day of November, 2017, for the purpose of submitting Measure E, an ordinance of the City of Brisbane amending section 5.20.100 of the Brisbane Municipal Code to increase the business license tax charged to recycling establishments; and

WHEREAS, the City Clerk of said City has duly posted and presented to the City Council of the City of Brisbane the County of San Mateo's certification of the votes cast for this Measure in said General Municipal Election; and

WHEREAS, said City Council has access to and has examined said certification of votes cast in said election.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Brisbane finds as follows:

1. The number of votes cast at said election was 1170; 877 in favor and 225 against.
2. That the record of votes cast in said election is shown on Exhibit "A" of the Certificate of the Chief Elections Official, attached hereto, and by such reference made a part hereof.
3. The Statement of the final results by the County of San Mateo Registrar of Voters as shown in Exhibit "A" and the results of the votes cast at the consolidated general and special municipal election are hereby ratified, confirmed and approved.
3. That Measure E, an ordinance of the City of Brisbane amending section 5.20.100 of the Brisbane municipal code to increase the business license tax charged to recycling establishments, passed by the majority needed.
