1. **PUBLIC HEARING: 805 Sierra Point Road; R-1 Residential District; Variance V-1-17;** Variance to allow development of a new single-family home with attached accessory dwelling unit on a 6,621 square-foot vacant, flag-shaped lot, that would exceed the 28 foot height limit by two feet. The tallest segment of the structure would measure 30 feet from grade; Mark Lee, Lee-Jagoe Architecture, Inc., applicant; JL Homeland Development Group LLC, owner; APN 007-522-200.
