Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on <u>Tuesday</u>, <u>November 28, 2017</u>, at 7:30 p.m., <u>Brisbane City Hall</u>, 50 Park Place, <u>Brisbane</u>, to consider the following matter:

REQUEST:

Use Permit and Habitat Conservation Plan Compliance for demolition of an existing single-family home and construction of a new 3,838 square foot single-family home on a 19,465 square foot lot. The project includes driveway improvements and removal of 15 trees from the site, of which 11 are collectively considered a protected tree per Brisbane Municipal Code Chapter

12.12 due to their trunk circumference.

The property is located within the San Bruno Mountain Area Habitat Conservation Plan (HCP). Consistent with the requirements of the HCP, a draft Operating Program has been prepared based on the findings of a biological resources assessment and will be considered for adoption.

## **ENVIRONMENTAL**

**STATUS:** 

Categorical Exemption per State CEQA Guidelines Section 15303(a)- this project falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 of the CEQA Guidelines do not apply, as confirmed by a biological resources assessment on file with the Community Development Department.
