1. **PUBLIC HEARING: Extension of Design Permit DP-1-15**; **23 San Bruno Avenue**; **NCRO-2 Neighborhood Commercial District**; Time Extension of Design Permit DP-1-15, originally approved by the Planning Commission on January 28th, 2016, which allowed for the construction of an approximately 31-foot high, three-story, mixed-use building, including four 1,250 sq. ft. to 1,323 sq. ft. residential units on the second and third floors and an approximately 550 sq. ft. ground floor commercial space and ground floor parking, to replace the existing single-story commercial building on a 5,000 sq. ft. lot; Lon Carter, applicant/owner.

Senior Planner Johnson gave the staff presentation.

Lon Carter, the applicant, addressed the Planning Commission in support of the application and answered questions of the Commission regarding the reason for the extension request.
