# **B.** Brisbane Library Annual Report

Tomika Price presented the Brisbane Library Annual Report. She reported that the library staff engaged over 6,000 youth adults in active learning and served 49,000 visitors. The library also became a fine-free institution in January of 2019.

Council thanked Ms. Price and the library staff for their successful year.

# C. Acknowledge Beacon Platinum Award from the Institute for Local Government for the City of Brisbane's Holistic Approach to Addressing Climate Change

Mayor Davis acknowledged the Beacon Platinum Award from the Institute for Local Government for the City of Brisbane's Holistic Approach to Addressing Climate Change.

Sustainability Management Analyst Etherton, reported that the City received the prestigious award for the City's voluntary efforts to reduce greenhouse gas emissions, save energy, and adopt policies that promote sustainability.

She added that the City of Brisbane received the Platinum-level Beacon Award for the following achievements:

- Agency GHG Reductions: Platinum Level 32% reductions
- Community GHG Reductions: Platinum Level 20% reductions
- Agency Energy Savings: Platinum Level 21% savings
- Natural Gas Savings: Platinum Level 24% savings
- Platinum Level Award in Sustainability Best Practices

#### **NEW BUSINESS**

A. Discussion Whether to Consider a Rent Control Ordinance Applicable to the Sierra Point Mobile Home Park

This item was pulled from the agenda.

B. Consider Introduction of Ordinance 643 to adopt the most recent version of the California Building Standards Codes (Code of Regulations, Title 24 or CBC) and the International Property Maintenance Code, Including Local Fire, Building Energy, and Electric Vehicle Reach Codes.

Community Development Director Swiecki reported that the proposed ordinance's purpose is to adopt the recent version of the California Building Standards Codes (Code of Regulations, Title 24 or CBC) and the International Property Maintenance Code, including local fire, building energy, and electric vehicle reach codes.

He added that the Ordinance will adopt the construction codes by updating Brisbane Municipal Code Chapter 15.04, Adoption of Construction Codes outlined in the staff report.

Additionally, Community Development Director Swiecki read into the record the amendments to Section 15.04.040 of the Brisbane Municipal Code, which included the addition of the following:

# 15.04.040 - Adoption of Construction Codes:

- 2019 California Residential Code Appendix H Patio Covers, Appendix J Existing Building and Structures, Appendix K Sound Transmission, and Appendix V Swimming Pool Safety Act
- 2019 California Building Code Appendix G Flood Resistant Construction, Appendix I Patio Covers, and Appendix J Grading.

To supplement the updated state codes, it is proposed that the City adopt several local modifications, known as 'reach codes' to address local fire hazards as well as energy and greenhouse gas emissions.

After some Council questions of Community Development Director Swiecki and Sustainability Management Analyst Etherton, Mayor Davis opened the floor for public comment.

<u>Terry Nagel, Tom Kabach, Diane Bailey, Dashiell Leeds, and Bruce Karney</u> spoke in support of the Ordinance 643.

After Council question and discussion with staff, Council directed staff to bring back the item at the next City Council Meeting on November 21, 2019 with more information regarding the City of Mountain View's Reach Code Ordinance and their exemptions and the manufacturing needs of Cannabis Businesses.

# C. Consider Approval of License Agreement with Brisbane Lunch Truck

City Manager Holstine reported that the Brisbane Lunch Truck, owned by Kristi Yawata and Tony Palmer, has reached an agreement with the former operator to purchase the truck and equipment but Ms. Yawata and Mr. Palmer will require a new license agreement with the City to operate at the Park and Ride lot.

He added that the license agreement is similar to the prior license agreement with some changes which included the following:

- The operators will be required to operate Monday-Friday 11 a.m. to 3 p.m. They may operate additional hours with the approval of the City. Exceptions to the hours of operation are anticipated for holidays.
- The operators may provide signage on site subject to the City Engineer's approval.
- The addition of signage is intended to assist the operators in better advertising their business and location to the general public. The limitation of access to the site and site lines for drivers shall be a consideration on location and size of signs.
- The operators will have a porta potty on site and will make it available to the general public during their hours of operation.

After some clarifying questions and Council discussion, CM Conway made a motion, seconded by CM Lentz, to approve the License Agreement with Brisbane Lunch Truck.
