Why do you want to be a member of the above Commission/Board?

Brisbane is a special place that I have fallen in love with since my wife and I bought our home here. I feel thankful everyday to live in a beautiful small town nestled against the San Bruno Mountain with such a strong, eco-conscious, and vibrant community.

My interest in joining the Planning Commission comes from my desire to preserve what makes Brisbane special, while ensuring the safety of our current and future residents. I also want us as a community to maintain control over all planning decisions and to continue our community's tradition of caring for the environment. These four values: preservation, safety, local autonomy, and environmental consciousness—along with my love of our community—inspire me to serve on the planning commission.

There is also a fifth value: compassion. What I love about Brisbane is that we are a community that cares for one another. We care through our Lions Club's Eyesight Conservation program making sure those in need have glasses and free eye exams. Compassion is there when a member of Brisbane Village Helping Hands helps a senior on a long overdue choir or when the Mothers of Brisbane support a new mom.

Compassion is an integral part of what makes Brisbane so special. It is a value I will bring if I am selected as a Planning Commissioner.

Compassion is evident in our town's current concerns about the Baylands development. The people of Brisbane care that the Baylands is a safe place to live and that the developer takes proper actions to remediate the land.

I also suspect that there are many people in town who, from a place of compassion, care about increasing the number of homes in town. This is a view I share—as long as we can add houses that are safe to live in, eco-friendly, and we are able to maintain our special small town character. I especially want to add homes that are affordable for our seniors. No one over the age of 65 in Brisbane should ever have to worry about staying here.

I came to this view as a result of my work as a hospice spiritual counselor. As you know, many Bay Area households need two incomes in order to maintain a home here. On an all too regular basis, I provide counseling to a grief-stricken loved one who has not only just lost someone very special yet is also going to lose his or her home as direct result of the lost income from their loved one's passing. I feel that someone who has just lost the love of his or her life should not also have to be figuring out where to live next.

I feel that we can address this problem in Brisbane, even if just on a relatively modest scale, by adding housing, especially affordable senior housing.

What do you feel you could contribute to the Commission/Board?

I have experience producing results and inspiring others as a leader.

I founded, ran, and am still involved in Elevate, a successful international non-profit, which is working with the Ugandan government to help parents identify and solve the problems in their children's school. Elevate currently has 14 employees and numerous studies indicate that our model for improving schools is the most cost effective at increasing children's scholastic performance. Through my recruitment efforts and management, I have more than doubled the number of volunteers at Kaiser Hospice in South San Francisco and San Francisco in my role as the volunteer coordinator.

I am told I bring a calming and soothing presence to stressful and emotionally charged situations. I am exceptionally good listener and I am able to make sure both sides feel heard during a deliberation. I have ample experience employing these skills as a spiritual counselor and crisis line counselor.
