CM Conway made a motion, seconded by CM O'Connell, to adopt the agenda as proposed. The motion was carried unanimously by all present.

A. Adopt Resolution 2017-58 to update the City's Conflict of Interest Code for designated positions

CM Conway made a motion, seconded by CM O'Connell, to approve Consent Calendar Item A. The motion was carried unanimously by all present.

OLD BUSINESS

A. Consider adoption of Resolution 2017-50, implementing General Plan Amendments to comply with Housing Element Programs H.B.1.a and H.B.1.b. and adopting the Parkside at Brisbane Village Precise Plan

Associate Planner Capasso provided an overview of the Supplemental Report received by City Council. This report addressed the following issues raised by City Council at their meeting on October 26, 2017:

- Corrected the Parkside Area Geographic subarea boundary
- Provided information on how the recent approval of the 16-unit senior housing development at 36-50 San Bruno Avenue and its impact on the City's Regional Housing Needs Assessment shortfall
- Provided information on whether the City can require residential projects in the Parkside area to the rental
- Provided information on the Density Bonus applications within the Parkside Plan Area
- Provided information on the discussion regarding Community Benefits
- Provided information on how labor representatives were included in the South San Francisco Downtown Specific Plan
- Provided information regarding whether Project Stabilization Agreements may be required as a condition of approval of development projects in the Parkside Plan
- Attached visualizations provided to the ad hoc subcommittee to illustrate massing of different building heights along Park Lane as seen from various points in the City
- Provided information on commercial and residential linkage (impact) fees
- Provided information on property owner outreach during the planning process

Council asked questions about height limits, housing density caps, housing to parking ratios, and community benefits. CM O'Connell thanked the staff and the Planning Commission for their work. She suggested that another meeting should be scheduled to discuss aspirational goals and community benefits not just for Parkside but for all City projects.

CM Davis stated that she is very excited about the project but does not like the Planning Commission's recommendation of 4 story building and tucked in parking. She also expressed that the community benefits discussion should be brought forth to the seated Council.

Mayor Liu expressed that the discussion of community benefits was a best practice from the South San Francisco Downtown Precise Plan.

After further Council discussion and clarification, CM O'Connell made a motion to strike language regarding PC's recommendation of a 4 story building with tuck in parking, keeping buildings in the

project area at 3 stories or less, and approve Resolution No. 2017-50 as amended. The motion was carried unanimously by all present.
