PARKING VIOLATIONS WITHIN THE CITY OF BRISBANE

DATE:

City Council Goals:

1. To provide public service that assures the safety of property and citizens residing, working or visiting in Brisbane. (#9)

Purpose:

The purpose of this resolution is to update the fines for parking violations to be more effective and consistent with other cities in the area.

Recommendation:

Staff recommends that the City Council adopt the attached Resolution 18-01, updating the penalties charged for parking violations.

Background:

California Vehicle Code Section 40203.5(a) gives the authority to the governing body of the jurisdiction where a violation is issued to establish a schedule of penalties for parking violations. The City of Brisbane has not raised its parking fines since September 13, 1999. (Resolution 99-45) A survey of South San Francisco, Daly City, Menlo Park and Pacifica revealed that the fines Brisbane currently charges are well below the average fines charged by other cities.

Discussion:

The primary purpose of imposing fines for parking violations is to achieve compliance with parking laws. If the fines are set too low, they are not an effective deterrent to illegal parking. If fines are too high, they may overly punitive in relation to the severity of the violation in question. Our goal is to create a safe and orderly parking environment in our neighborhoods.

Fiscal Impact:

Last year the City of Brisbane collected a total of \$8,738 in parking fines.

I would expect that initially revenue would rise in relation to the increase in the fines. However, since one of the purposes behind increasing fines is to gain more compliance, revenue could later decrease by some degree as more compliance is achieved. Since the increase in fines is moderately substantial (73%), I believe that an overall increase in revenue will result.

Measure of Success:

Success can be measured by increased compliance with parking laws and increased revenue.
