PRESENTATION AND PROCLAMATION

A. Public Works Week

Mayor Conway read the Proclamation recognizing May 21-27, 2018 as Public Works Week. City Engineer Breault accepted the Proclamation on behalf of the Public Works Department. Council congratulated the Public Works staff members for all their hard work and dedication.

B. Receive an Update from Get Us Moving San Mateo County

Matt Wilson, SamTrans staff, provided an update from Get Us Moving San Mateo County. Mr. Wilson encouraged the members of the public to continue to get involved, attend a Town Hall meeting and spread the word about Get Us Moving San Mateo County.

C. Presentation Regarding Baylands Soils Processing

City Engineer Breault stated that in response to news stories on the Hunters Point Naval Shipyard (HPNS) in San Francisco and speculation that radioactive soils may have been brought to Brisbane, more specifically to the Soils Processing business on the Baylands, the City is proposing four courses of action to address this issue:

- 1. Conduct Records Search Under our Memorandum of Agreement with the property owner (UPC), the City has a right to audit operations on the site.
- 2. Create a Plan for Soils Analysis –City staff has approached consultant Dr. G. Fred Lee to assist in developing a strategy of how we would explore the landfill site to test materials for radioactive materials.
- 3. Contact U.S Attorney and Lawyers representing Whistle Blowers –the City Attorney will work with the following parties to see if there is any information regarding the allegations that toxic soils have been brought to Brisbane.
- 4. Investigate further the news article regarding bringing of material to Recology

After some Council questions and discussion, CM O'Connell wants Dr. Lee's plan to include soil testing when soil is moved within the site and when it is exported.

City Engineer Breault stated that he will forward to the Council the source document used by the news reporter for their story.

The Council discussed the issue of unification of the entire Baylands under the jurisdiction of the Department of Toxic Substances Control (DTSC). Council directed staff to contact UPC and let them know that the Council wants the unification of entire Baylands under the jurisdiction of the Department of Toxic Substances Control (DTSC).

<u>Dana Dillworth</u> asked the Council if they have proof that no contaminated materials were brought into Brisbane.

Clara Johnson made a comment about the Remedial Action Plan.

<u>Michele Salmon</u> stated that there needs to be full disclosure of the soils manifest, including activity in the quarry.

After further Council discussion and questions, CM O'Connell directed staff to look into the class action lawsuit Dana Dillworth mentioned in her public comment, and to look into the importation activity happening in the quarry.
