

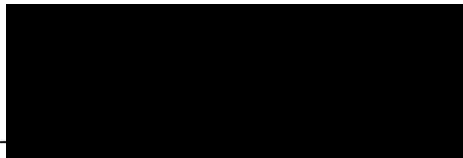

What do you feel you could contribute to the Commission/Board?

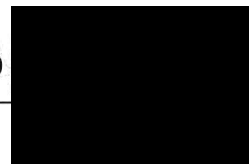
